Coronavirus Relief Grant Application Form

MUST BE RETURNED TO HVPUD BY MONDAY, NOVEMBER 2, 2020 TO BE ELIGIBLE FOR THE GRANT

The Coronavirus Relief Grant Application Form <u>MUST</u> be returned to HVPUD prior to the disbursement of three (3) months credit of the monthly water rate. This three (3) months credit <u>DOES NOT</u> cover any excess overages, only the monthly base payment. HVPUD clients are responsible for the payment of any and all overages.

Eligible HVPUD clients <u>MUST</u> be a Hoopa Tribal Member <u>OR</u> have a Hoopa Tribal member permanently residing in their home.

By submitting this grant application, you are verifying that you are an eligible Hoopa Tribal Member or have a Hoopa Tribal Member living in your home. In addition, you are requesting assistance in direct correlation to a financial hardship endured as a result of the COVID-19 pandemic.

- 1. HVPUD certifies that the distributed funds will be used only to cover those costs that:
 - a. Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19), as described and defined by official federal guidance on Section 601(d) of the Social Security Act, as added by Section 5001 of Public Law 116-136;
 - b. Were not accounted for in the budget most recently approved as of March 27, 2020; and
 - c. Were or will be incurred during the period that begins on March 1, 2020, and ends on December 1, 2020.
- 2. HVPUD will maintain copies of any grant applications and accounting records to document the funds distributed.
